Have had meetings/conversations about the Potato Patch "garage." This appears to be moving forward with our input

#### Personnel

Registration is open for the AZ Wildland Fire Academy. We have 15 scholarship days. We could have as many as five recruits for S-130/190 and at least one firefighter is interested in an advanced class. We would pay out of pocket for days beyond our scholarship allotment.

# Yavapai County Fire Chiefs

Had a presentation from AT&T for a service for emergency responders that allows for their "traffic" to be prioritized when circuits are busy. AT&T's coverage here is inadequate for now but we will have access to this when it becomes functional.

#### **PRCC**

There are several senior leaders from other departments who are retiring in the next year or two. This doesn't necessarily impact us directly, but we have good relationships with these folks and need to continue reliable partners for whoever fills those shoes.

#### Other Item

Yavapai Fire Protection is a local 501c3 that CAFMA Chief Freitag believes is a fraudulent endeavor. Yavapai Fire Protection is making a lot of claims that appear to be questionable in the context to what they can do and where they can do. Freitag asserts they have no qualifications for the services they are trying to offer. I first became aware of them several months ago, I just figured they were just a private contracting company for large wildland fires but Freitag says they are trying to provide service some how in other departments' service areas. They have made no such attempt in our area that I am aware of.

Discussed possibly looking to add new equipment which would be a lighted flashing type device to alert people when equipment is coming in out of the station as a means to protect traffic around the fire station area. Everyone feels it would be a good investment and we should be able to use the budget for this type of purchase. Mark Herrin said that his company, Outback Creations, would pay for them.
