Treasurer Report

Balance sheet assets of \$291,509
P&L Income for July was \$10,692, and the Expenses were \$31,231. Leaving us with a loss of \$20,539. This is from FF payroll from summer fires. We paid firefighters while we wait for

the reimbursement from the state. Since we are on a cash basis this shows as a loss on the P&L.

Roger also stated that we had some issues with rescue 81, it had to be towed from Goodwin fire, and he feels the income it generated should cover the repair.

Motion to accept the Treasure Report by Jonny O seconded by Dan. Motion passed.

Committee Reports

Bill wanted to ask Loren about Fire wise checks. Loren stated the two checks we received are from chip and haul. He also asked if there are any plans for this year. Loren stated that they might find some dollars for program this fall but currently no other funds available. Bill stated the consensus is that we like the program we just do not like the parking lot being torn up. Going forward we have to have funds to repair the lot after the chip and haul. Bill asked if there is another site for chip and haul. Loren stated that our lot is the only viable site. Bill thanked Loren and asked he keep us posted as to the plans for the program.

Old Business

Chipotle fundraiser

It is set for this Monday; it will be an all day. It would be nice to have fire truck there handing out flyers and have a boot for donations. Roger will rally the troops and figure it out. The goal is to be there till around dark. Johnny will follow up on any issues with parking the truck in the lot. The Board would like to thank Dan's son Case for putting this together with his employer.

Fire Fighter Appreciation Dinner / 50 anniversary is on 9/3 from 3 pm to 6 pm. Bill discussed the logistics for the event. We will do the 90 Lb pig in the roaster with another 60 lbs of pork roasts. Dinner served at 4 PM, Johnny will MC and Roger will speak around 5 PM to address the community. We will have the trucks moved by 8 or 9 and the tables set by noon. Bill will talk to Matt about the cooking of the pig. Roger has talked to all the firefighters about attending so they can be recognized.

Budget

Bill had some questions about the budget. First he asked about the Bond Coverage. Johnny stated that the Bond coverage costs \$1131 and it protects our assets for up to \$150K. Commercial auto, what was the \$450 line item from last year? It was thought that we might have added a vehicle mid cycle. Johnny will check on it and let Steve know. The commercial package cost \$12,529 last year to around \$13000 for next year. Workers compensations \$7640, for last year and increased to \$8000. Bill also asked to make sure we have budget money for roof. There is \$5K set aside in the budget for that expense. Steve will make these adjustments to the budget. Johnny, motions to accept the amended budget Terry P seconds budget all in favor aye, motions accepted.

Elections
