President Report

We talked about insurance in the executive session. The season is over and we will all be preparing for winter. Dan said had a meeting with the county regarding Big Bug Mesa and the county will review the easements and the forest service and get back to them.

Secretary Report

All documents and files have been updated to the website. The corporate commission forms have been updated with the new statutory agent.

show Total Income at \$63,709 versus a budget of \$48,494 and Total Expense at \$53,035 versus a budget of \$51,970. The Net Income is \$10,673 versus a budget of \$-3,476. The board continued the conversation about repairing or replacing the pump house and adding some additional storage for snow blower.

Thee are 2 options.

- 1.We could replace the pump house with a larger building to hold additional items.
- 2. We could add another small shed to hold the snow blower, barbeque and some of the other items from the back of the firehouse. We would than just repair the current pump house.

The cost was estimated at \$5000 and this would be added to the budget.
