6.0 - Fire Chief Report

Calls

- Four medical calls and one structure fire (it turned out not to be).

Training

- Truck PMs and nozzles. Sixteen firefighters have already successfully pack tested for the 2021 fire season.

Fleet

Hope to start sending apparatus to CAFMA Fleet Maintenance in late March.

Facilities

 We learned that snow in the front of the Potato Patch station does not melt quickly. Need to consider asking the community up there if someone can plow out the front.

Personnel

- Doug Berg is now our wildland coordinator; this is a formalized role for our interaction with State Forestry.
- We may now have three qualified engine bosses, the third being a recruit who recently moved here, brought into the department by Jon Lee at his EMT class.

PRCC

- Adding two consoles for two more dispatchers \$100,000. Replacing the generator which died \$60,000, upgrading the dispatching software \$260,000. Our portion of these capital expenditures will all fit under our \$5000 cap which we pay 1/12 of monthly. These numbers are determined on a prorated bases by calls for service. We had 66 calls in the trailing 12 months versus 14,325 for CAFMA and over 10,000 for Prescott Fire.
