She will also be able to tone out for back up if a call escalates into something more than we expect like a patient unexpectedly needing to fly to Phoenix. She will not be on location with us, she will do this from home or possibly the station house depending on the nature of the incident.

We have engaged with Yavapai Regional Medical Center (YRMC) for Covid 19 testing.

Unrelated to testing, we have been offered vaccines when available through YRMC. We've had five firefighters express interest. This came about before the Pfizer news so we don't know whether this program will still be happening.

The AZ Wildland Fire Academy will be a mix of online and classroom and in person training. We hope to be putting three recruits through but that remains to be seen.
