Loren – week ago Wednesday Firiewise got final approval on a \$70K grant. This will fund the Chip & Haul events. Loren would like to have one set for early March with a second set for the following year.

Loren - Firewise is recording time with a new timesheet that is available from Loren or on their website..

President Report - Time Index: 05:14

We had a discussion about the bylaw presented by the committee. On the 22 November we will meet with the committee for a discussion and hammer out the final language.

Secretary Report - Time Index: 06:29

The minutes from the October Meeting were distributed to the Board members and posted on the website along with the Audio file from the meeting.

39 returns were received from the most recent mailing. The addresses used for that mailing came from the most up-to-date data available from Yavapai County. The breakdown of the reasons for the returns is shown below.

- 2 returned as Vacant by the Postal Service
- 2 returned as Unable to Forward by the Postal Service
- 3 returned as Not Deliverable As Addressed
- 4 returned by the Postal Service where research shows that there are new Owners of Record
- 14 returned by the Postal Service with updated addressed and research shows those addresses are now
 correct in the County data.

• 14 – returned by the Postal Service with updated addresses and research shows that the County data is NOT updated (our information is more current)

I will hold the 14 where our information is more current and will check the data for those addresses to see if they have been updated. Also the current value of our account with the postal service is \$186.39 as of 6 October 14. This account is used to cover any change of address updates which are returned to us by the Postal Service.

Thank You letters have been sent to the seven contractors who discounted or donated services and materials for the Storage Area and Break Room construction project.

As a summary on the construction project, In Kind Services donated by Walker Residents was valued at \$12,290. In Kind Donations by Walker Residents was valued at \$5350. In Kind Services and Material donated by Contractors was valued at \$7,238.

Motion to wave with the reading of the minutes was made by Terry and seconded by Vic . Vote. Passed. 6/0

Cash on hand \$130K. Overall we are ahead of budget by \$10K. Expenses are remaining below budget. The last letter to the community yielded about \$10K in donations.

Bill commented that Walker Trash had additional funds to transfer.

Fire Chief Report-Time Index: 14:23

Calls One medical call. Personnel We have started enrolling people into the Wildfire Academy for 2015 including a new recruit for the basic class. Fleet Fleet still going through annual servicing. Engine 86 is in for servicing now. Training We continued our structure training module, next we will be focusing EMS for the next few months and then Wildland in the spring. Facilities We are enjoying the extra room both in the main garage, back shed and the office. Western Yavapai Chiefs Association I will continue on as VP for another year. PRCC No report. PAUWIC We are participating in this year's Christmas Parade.

Regarding our radios: We are looking at installing an additional repeater at the communications building to accommodate some dead spots. As far as using the Groom Creek Channel, only the incident commander will use that channel. All other radio traffic has been moved off to the Walker Fire repeater. This has reduced traffic by 90% and has satisfied Groom Creek's original issue. Long range it is not

necessary for us to have our own channel.

Regarding water tenders: We should be planning on spending roughly \$40K for a mid to late 90's vehicle.

A new one would be in the area of \$200K. Our current trucks are early 90's. To get into the 2000's

would be a significant jump.
