# **Treasurer's Report**

WFPA has not yet completed our FY as we conclude at the end of the month. For June through April, thanks to community, income \$99,738 .v. budget of \$93,088. A majority of funds donated go to support equipment, fleet, station. The board serves without salary. We have an accounting firm in Prescott who manages our funds and expense. We provided the membership complete transparency. The website contains a monthly report of our financials. One request we make of the membership; at times we get donations here at the fire station. Those donations may sit for two or three weeks before one of the board members picks them up for deposit. Please use our mailing address PO Box 10174 Prescott 86304 to send your donations. It is attended by our accounting firm who will process the donation and provide you with prompter attention.

#### **Fire Chief Report**

25 calls over the year with 16 of the calls being medical. Others were smoke investigation and only one fire. We are very fortunate. Call 911 with any emergency, not a firefighter that you may know. It is the fastest way to get a response. Smart 911 ( <a href="www.smart911.com">www.smart911.com</a>) will notify you via cell phone should an emergency arise. It is worth enrolling.

Highlight of the year is our new water tender – tender 83. We asked for donations for this vehicle and the community responded in a big way. Thanks to the community for doing this for us.

Prescott Fire's issues with pensions is leading to brown outs at stations – reduced staffing. There is risk that they may have to permanently close a station. Chino and Yavapai Fire Districts are margining out of necessity. More currently Groom Creek is facing problems. Juniper Woods had to close their doors due to lack of donations. In our community, your donations keep us going.

We've had good luck with new recruits! Three new recruits. One is already red-carded and two other are very close. Assistant Chief Keegan is pursuing the paramedic role. We will now have 5 paramedics at the department.

Firefighters at the meeting were recognized for their service and introduced.

### FireWise (Loren Bykerk)

Our 2016 Chip and Haul was a big success. Last year 24.5 roll offs, this year 19. Volunteers reported their hours. 33 turned in valid time sheets amounting to over \$12K in time. Loren Thanked the WFPA for the use of the parking lot and assistance with costs. Several residents were thanked for their assistance as well as service providers. Also \$1932 was donated via the WCAA website or at the Sundae Saturday events. We completed 16

assessments last year and 10 homes had clearings completed around their homes. Two grants with monies to have property treated are still available. These are 90/10 grants. Contact Loren Bykerk.

One member mentioned that insurance companies are evaluating neighborhoods for underwriting.
