Treasurer Report

Steve presented the financials for August. The Balance Sheet remains very strong at \$299,105 in Total Assets. On the Profit and Loss, the Total

Income was \$6,533 versus a budget of \$7,972. Total Expenses were \$13,074 versus a budget of \$13,141. Year to Date our Total Income is \$33,793 versus a budget of \$30,520 and Total Expenses of \$25,831 versus a budget of \$31,161 yielding a favorable \$8,603.

John motions to accept treasurer report and Ed seconds, Motion approved.

Committee Reports

Discussed upcoming October 1 Fire Fighter appreciation day. This is our 6th year honoring and celebrating the volunteer Firefighters.

Bill will arrange the delivery and preparation of the food for the event He plans on purchasing a 90 lb suckling pig with an additional 40 lbs of pork with side dish of beans. It is a potluck dinner so residents of the community are encouraged to bring their favorite family side dishes.

John will send out notice to the community reminding them of the event and that this is a potluck event, He will also request for all attendees bring lawn chairs since last year seating was in short supply.

We also discussed replacing some of old chairs for the firehouse since they are wearing out.
