Treasurer Report

The Balance Sheet shows Total Assets of $\$ 280,853$. The Profit and Loss shows Total Income of $\$ 3,678$ versus a budget of $\$ 6,510$. The Total Expenses were $\$ 7,205$ versus a budget of $\$ 8,295$ for a Net Loss of $\$ 3,527$. Year to Date our Total Income is $\$ 11,210$ below budget and Total Expenses are $\$ 8,492$ below budget leaving us with a net loss of $\$ 2,718$.

Steve forwarded the reports and they have been uploaded. Bill commented that we are still fine financially. No other comments regarding the treasurer report. The motion to accept Steve's report via email presented by Terry P. Rudy motioned to accept minutes. All in favor Aye. Motion has passed.

We have our Saturday Sundae social events over the summer and WCAA wants to set the summer schedule. The website has it listed on $9 / 3$. It was brought to the attention of the board that the proceeds of this events tare donated to the chip and haul.

Kim lives up on Frampton Hill and is wondering about the logging and the mess with the piles of lumber. She wants to know if we can reach out to the forest service to meet with the residents regarding logging.

## Brief Board discussion about public comments

It was explained to Victoria and Karla that we are trying to get the schedule set for WFPA summer events and at this time it is still moving target. Bill stated we should have the schedule finalized within the next month or so.

Bill responded to Kim that we do not have any control of what the forest service does. As a board we will not be involved with this. Loren stated that at our last annual WCAA meeting the forest service had people attend and they will be at our meeting this year. The community should have an opportunity to address their concerns then. It was also mentioned that The Forest Service had individuals attend Walker Day last year and they should also attend this year.

Firefighter appreciation day is tentatively set for $10 / 7$ if we do not combine this day with the $50^{\text {th }}$ anniversary day.
