From The Fire Chief:

After a relatively quiet 2024, the 2025 fire season will pose some challenges. First of course is the weather, we had a very dry winter which is typical of a La Nina weather pattern. In January we had a local wildfire and of course in February, just south of us was the Brady Fire which very quickly turned into a 400-acre incident. It will be crucial for the 2025 fire season that we make good decisions about anything that could cause a fire. Most wildland fires are human caused by human error. Please comply with seasonal fire restrictions when they are imposed which we believe will be earlier than normal. And if you have a **short-term rental, please do not allow them to have warming (campfires) at any time.** We can't expect people visiting from outside the area to understand wildland fire danger.

We wanted to devote some space in this letter to our planning process with some recap and some future projects. For the last few summers, we've been able to send a truck to wildland fires outside our area which brings revenue into the department. This revenue is generally earmarked for new fire apparatus. We brought in roughly ¼ of the expense for Engine 83, the new red truck, from the wildland program, got half the expense from a grant and the final quarter of the cost from designated donations from the community. Engine 83 brought in even more revenue which allowed us to upgrade Engine 86 with the green truck. The wildland program paid for about ¾ of the expense for that truck with the rest coming from designated donations from the community.

If we are able to get out on wildland fire assignments this year, we've already had one, we will be turning our attention to replacing two of our three water tenders, the big water trucks. The two we hope to replace are more than 30 years old. Water tenders are less expensive than engines and buying two of them at the same time is plausible, but it will depend on how busy we are with out-of-area assignments. We are also exploring ways to add more space for our fleet, possibly with another building on the property with the main stationhouse. As of this writing we are still in the planning stages but depending on expense and how much space, we hope to house two wildland fire apparatus and possibly a UTV later down the line.



As has been the case for many years, your best source for reliable and current information during a large fire or other incident is the department's Facebook page. From The Treasurer:

Hello fellow Walkerites. Winter is almost over! I am looking forward to another great season on the mountain. As I write this, we are still in the early stages of budget planning and preparation for the next fiscal year which begins in June. Mixing event planning, fire season predictions, department needs, etc. into a budget plan can be quite a task. The annual meeting is coming up soon and I will be reporting a more in-depth look at our financial status and forecast.

Here is a quick overview. Year to Date expenses have been about \$115,000 with 3 months left till fiscal year end. Roughly 50% of that was for vehicle expenses, medical and firefighting supplies and communications. 30% was for insurance, bookkeeping, utilities, office supplies and things like credit card processing from PayPal. The other 20% was for fundraising expenses.

Contribution income this year has returned to previous levels due to some very generous donations. YTD donations have been about \$94,000. Fundraising this year has brought in about \$48,000. This is from a huge effort from our fundraising team and participation of the community.

Thanks to our Wildland program we were able to upgrade the fleet this year replacing Engine 86 without impacting our cash reserves too much. I know there is more work to do here as some of our water tenders are getting old.

I recently had the opportunity to spend the better part of the week at the AZ Wildland Incident management Academy (AWIMA) for a class. I was told this was the largest gathering of firefighter personnel in the nation. There were over 1000 people taking classes to improve skills and gain qualifications. This gave me a chance to gain a little insight as to how other departments work. Cost, funding and manpower seemed to be recurring topics of concern. The WFPA board and us as a community continues to manage cost and funding. Together we need to also take care of our volunteer manpower.

Thank you all for making Walker Fire a great department.

Firewise:

2025 Walker Chip & Haul

Walker residents, you may drop your slash at the Walker Firehouse beginning June 21, 2025 and ending on July 20, 2025.

Note - Only four weeks again this year. Grinding is scheduled to begin on July 21. Remember – Forest vegetation only! No root balls, dirt, rocks, metal, lumber, bricks/blocks, plastic bags, garbage or trash. All bags must be emptied.

For your safety, access to the slash pile will be restricted again this year whenever the grinder is operating. For your safety, please observe all warning signs

As in past years, fourteen years and counting, WCAA (Walker Community Action Alliance) has not and does not charge Walker residents to use Chip & Haul services. This is a community project of “Residents Helping Residents Save Lives” WCAA provides funding for chipping and hauling through grants, fund raisers and donations. WFPA (Walker Fire Protection Association) has also helped WCAA in some past years to make up differences in costs that WCAA could not meet. This year, WFPA and WCAA are asking Chip & Haul participants for financial assistance to help cover the increasing costs and for preparing and restoring the fire department’s parking area used for Chip & Haul.

Healthy Forest Initiative Grant HFI 23-353

WCAA Walker Firewise is currently administering a \$162,528.00 reimbursable grant for Walker property owners. As of now, your Firewise team has performed 16 Wildfire Risk Assessments, covering over 26 acres. We have submitted for \$15,898.53 to reimburse homeowners who have already had their parcels treated. Several other jobs are currently in various stages of completion.

Walker Trash Collection Services:

The trash subscription runs from January to December for 12 months. Six-month subscriptions are Jan. 1st thru June 30th, or July 1st thru Dec. 31st.

The rates are \$250.00 for 12 months; and \$175.00 for 6 months.

We now have electronic locks for the dumpsters. Information for the locks / app are provided with signed contract and payment. We operate this service for your convenience and to avoid people burning their garbage, especially during the dry months.

THIS SERVICE IS FOR HOUSEHOLD GARBAGE ONLY!

We have video surveillance surrounding the dumpster area to help monitor activities. If the dumpsters are full, please do not leave your trash on the ground. Please take all other materials to the dump.

The City of Prescott Transfer Station is located at 2800 Sundog Ranch Road.



The app cannot be shared with short term renters, cleaning companies or contractors. All short-term rental properties are to purchase a subscription for the full term of use. The responsibility for the disposal of the trash from short term rentals is the responsibility of the rental manager.

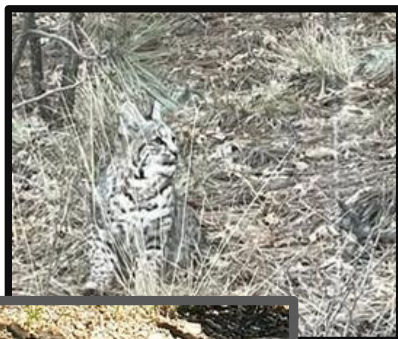
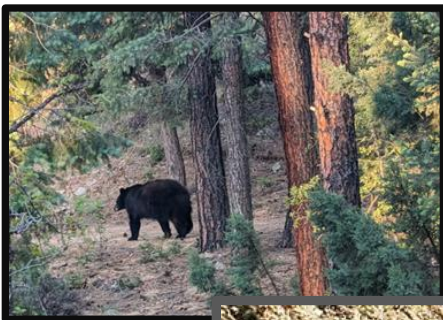

Walker Fire Protection Association, Inc. - Proxy and Instructions:

As provided for in the bylaws of the Walker Fire Protection Association, Inc. ("WFPA"), proxy voting is permitted for the Annual Meeting which will be held at the WFPA Fire Station located at 4980 E. Walker Road, Prescott, AZ 86303, at 9:00am, Saturday May 24th, 2025. Proxies are available upon request by email at secretary@walkerfire.org, or by phone request at 480-329-8443 or available for download on the WFPA website at www.walkerfire.org. A proxy for each person voting must be correctly completed, signed and returned either by mail to WFPA, PO Box 10174, Prescott, Arizona 86304 or emailed to: secretary@walkerfire.org, attention WFPA Secretary and received no later than Thursday May 21st, 2025, or can be physically delivered to the WFPA Secretary at the Annual Meeting between 9:00 and 10:00 a.m., on May 24th, 2025.

WFPA Member eligibility to vote is defined by the WFPA bylaws, Article III "Members" and summarized as; 1) owning or participating in the ownership of property within a three mile radius of the Fire Station, property included in the Potato Patch Area Association or otherwise accepted as a Member under guidelines/criteria adopted, from time to time, by the WFPA Board of Directors and 2) consent by State Statute as defined in section 3.1.1.2 through 3.1.1.2.2.6.

The number of total votes eligible by Members shall not exceed one vote per Member and no more than two votes for property ownership held in "joint" ownership interest as defined in Section 3.4 through 3.4.6 of the WFPA bylaws. The total votes eligible are limited as defined, regardless of the number of parcels owned or ownership participation as defined in section 3.9 of the WFPA bylaws.

Proxy will be verified for eligibility and against a Member roster with a record date of May 24th, 2025. Proxy qualification will be reviewed and verified with final eligibility determined by the WFPA Secretary. Any proxies not signed, not in proper order or not matching the Member roster will be set aside and considered invalid.

Yavapai County Emergency Management has been busy developing “evacuation zones” A new web page and a new mobile app each allow you to enter your address so that you can receive status alerts. The alerts will designate the “Ready, Set, or Go” status for your zone.

The mobile app is: “genasys protect” and the web page can be accessed at “yavapaiready.gov”. Scroll down to “Evacuation Zones” or go directly to “protect.genasys.com”.

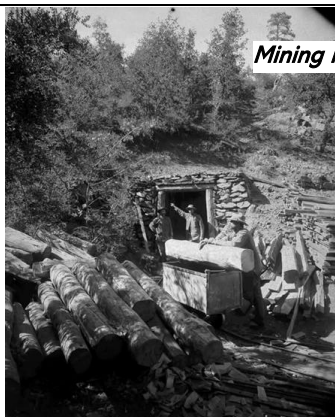
If you haven't already done so, you should also sign up for **alertYAVAPAI** (or google it) to receive notifications by any two or all of the following: email, text or mobile phone. Yavapai County no longer uses “Code Red”. In all cases, if you receive a “GO” notification, go now! Do not stay to defend.

The Yavapai County Sheriff's Posse, under the direction of the Yavapai County Sheriff, will still be responsible for directing evacuations in the event of an emergency.

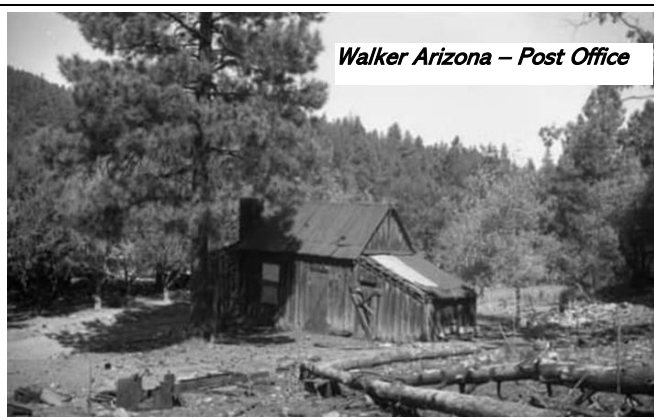
Yavapai County Community Health Emergency Preparedness – Functional Needs Evacuation

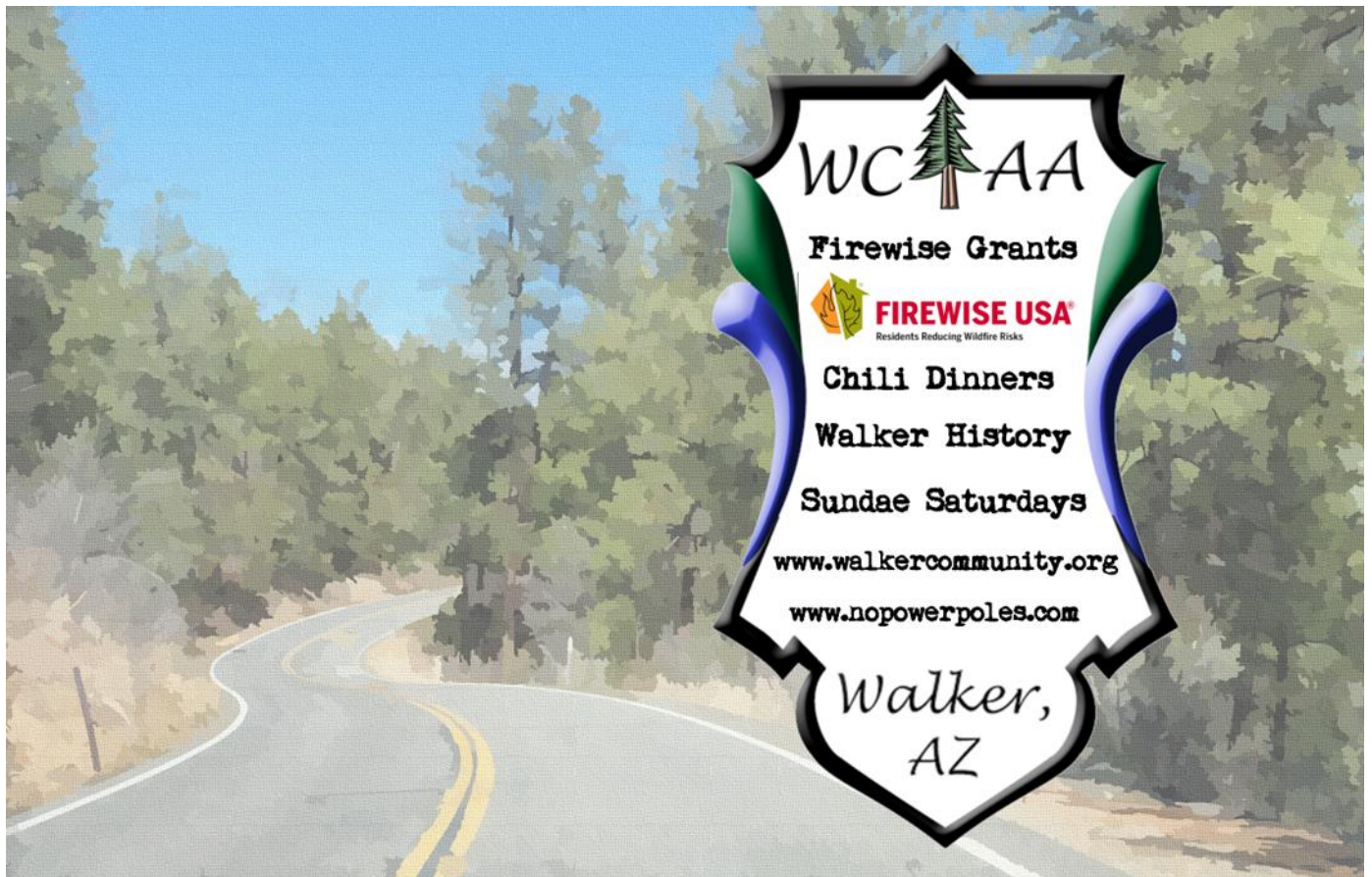
