

FROM THE PRESIDENT...

Dear Community,

There are several topics I want to cover. The problem is keeping them Pithy enough so it will keep your interest.

Last December, our secretary Russ Courtney was sorting though some old WFPA files in the office. He found a file that included old photos and documents. One, dated March 5, 1968 was a donation request letter from Robert J Potter, the President of the newly formed Walker Fire Protection Association. In that letter Bob Potter identifies that the plan to form the Association that had begun in November of 1967.

There was a Prescott Courier Article from May 1968, announcing that Walker had received its first Fire Truck from Military Surplus channels through cooperation by the State Forester's Office. Donations from the community paid for reconditioning and equipping the truck.

There are pictures of the construction of the first Fire Station at 5881 Walker Rd (the corner of what is now know as Hummingbird Hill Rd and Walker Rd). There are photos of the Fire Truck at what appears to be an early if not the first Walker Day held at the Potter Property.

Scans of these documents and photos are available on the walkerfire.org web site in the Community Gallery.

Robert J Potter was my Grandfather. Seeing his donation letter (that sounds like current letters) and his handwritten letters have brought back fond memories of those days when the number of property owners only totaled 300.

Our community is near 1300 now, and still operates on your generosity to keep the WFPA afloat. Over the years' you have done a great job of supporting the WFPA. During the intervening times a lot has happened. There have been rifts and turmoil. Currently, we have enjoyed several years of harmony, much as the original founding members had. Your current Board has truly been a pleasure to work with. They have a wide variety of backgrounds and are all dedicated to betterment of the WFPA. They handled their positions in a professional and businesslike manner. We have endeavored to treat Members with respect who have complaints and/or issues and we continue to encourage them to bring those issues to the Board. Some of the issues are not directly related to the operation of the Fire Department. Those issues are directed to Volunteers from the Community to see if they can assist with resolving them. Thank you to those who have assisted.

Roger Nusbaum, our Fire Chief, continues to do a fantastic job with the day to day operations of the Walker Fire Department and will handle any operations related issues. We owe Roger and his Volunteers a big debt of gratitude.

The Fire Wise program under Loren Bykerk's management continues to receive grants for the removal of combustibles. The Chipper Day program is obviously very popular with the Community. Just look at the pile of slash that accumulated the minute the lot was open to receive it.

Remember this is a 90/10 grant and all your time and expense to gather the slash is useful to offset out of pocket expenses. Loren will have the forms needed to document your expenses and time to assist this 90/10 grant. This program is a great way for you to reduce fuels off your property. Please let Loren know if you need assistance with moving slash off your property.

Our last Fall Newsletter, we experimented with 'Going Green' by not sending a hard copy multi-paged Newsletter. We used emails and a post card announcing the Newsletter would be available on the website. This was an effort to cut printing and postage expenses.

The result was a reduction in donations. The Newsletters serve as a reminder to the Community to give to the WFPA. Since we depend solely on donations any downturn causes concern. Especially since we are needing to upgrade our two Water Tenders and will be making a special request for that specific purpose. Special fund drives can impact operational giving so please remember us. We

would like to be able to plan for this expense out of the general operational budgeting and not a special fund or drive. This is where your continued support and annual donations make a difference.

In December we were notified that a written request had been made to the Groom Creek Fire District to annex the Walker/Big Bug/Potato Patch areas. There was more than a little concern about this process and the potential increases in our property taxes. We communicated our concerns with the GC Fire Chief. I attended their next Board Meeting in January and addressed their Board with those concerns as well. Our last communication from them was in February to the effect that the Groom Creek Board decided the annexation was not viable and the issue is now dead.

During the time I have been on the Board there have been several discussions about people parking in our parking lot and prospecting in Lynx Creek.

The WFPA does own a small part of the Lynx Creek but the majority of the creek is in private hands other than the WFPA. For some reason the prospecting periodicals have listed our location as a place open to prospectors. Some of their activities have been pretty aggressive, digging huge holes in the bank that are left unfilled. Some of these people have used our water and we received a complaint that they were leaving human waste that made it difficult to walk dogs in the area. This causes concern for the kids that attend our social functions that play in the creek.

I do not want to be the prospecting police, but I also do not want the problems some of these prospectors are leaving behind. We will be posting signs that parking in the parking lot will be restricted to WFPA Authorized parking.

Occasionally we find other vehicles parked on our lot. While this has not been a big issue, it has been increasing that people park ATV trailers while they ride in the area. We are open to short term requests (there will be a Wedding nearby and the family has asked permission for guests to park there). It's always best to notify us if you plan to leave a car there and never park in front of the Fire Station.

There are a few proposed changes to the Bylaws that need to be approved by 2/3 vote of the Membership this upcoming Annual Meeting to be held Saturday May 23, 2015 (Memorial Day Weekend). While some of the changes are clerical in nature (address correction created by Yavapai County, typo's and spelling errors) there are proposed changes regarding definition of Membership and voting rights. These changes were prompted by confusion and differing opinions about the current Bylaws.

The early history of the WFPA was anyone that showed up at the annual meeting could vote. This worked until someone claimed that non-property owners were being "bussed in" to sway elections.

Although this claim was not factual there became a need to address the claim. After lengthy discussions, the Bylaws were changed to include a definitive area (3 miles from Firehouse) was created and voting rights were specifically restricted to property owners named on the title. Then because many properties are owned by Family Corporations, Trusts and Partnerships the Bylaws had to contain language to identify voting rights for people involved in those kind of entities. There was a negotiated consensus that Corporations, partnerships and Trusts should be limited to two votes. So, we have complex language identifying those requirements and restrictions. (Yavapai County Assessor records are what the WFPA uses to confirm property ownership)

Complicating this is State Law that requires that a "Member" agree to be a "Member." meaning the WFPA could not just say all property owners are Members but we had to have a method for Members to accept Membership. We were threatened with legal action if we did not and we were accused of operating outside State Statute.

As it happens we were not operating outside the Bylaws or State Statutes. Agreement can be either Overt or Implied. Asking for a Ballot is Implied that you are agreeing to be a member. Walking up and asking for a ballot is permitted under state law if not prohibited by the Bylaws.

We give every property owner notice via our newsletter and website. So by definition all "Members" are notified of the Annual Meeting in May.

The current Bylaws require annual renewal of Membership. There are clauses in the current Bylaws that have been construed that there are other restrictions for Membership. That is not the case.

The proposed Bylaws that are attached to this newsletter simplify this language. Recommended changes are underscored.

Once a Member always a Member as long as you own property. All property owners need to do is walk up and ask for a Ballot. There is no other requirement for Membership. Persons who claim to represent a Corporation, Trust or Partnership are accepted at face value and can only be challenged by the official representative of the entity.

There are people who want more restrictions for Membership. They do not agree with the proposed Bylaws.

It is the unanimous recommendation of the WFPA Board that you approve the new Bylaws.

"Membership" to the WFPA is not required for us to respond to your need of assistance. If you need us and we can get there we are coming. Just call 911.

The WFPA will answer all calls it can respond to assist the Community, regardless of the Bylaw voting criteria.

Looking forward to see you all at the Pancake Breakfasts, Bingo, Annual Meeting, Walker Day, Fire Fighter Appreciation Pig Roast and of course the Monthly Board Meetings.

FROM THE FIRE CHIEF...

As we look forward to the upcoming wildfire season, we also look back to the 2014 wildfire season which was fortunately mild in terms of number of fires and acres burned but in those fires we benefitted from the US Forest Service's commitment to have an increased presence in the Prescott Area and to make responding to the Walker area a very high priority. This allowed us to work alongside Forest Service crews and further enhance our relationship with them. We look forward to continuing to work alongside the Forest Service this year should there be any fire activity in our area.

For the last couple of years we have talked about the need for a new water tender, we want to add a water tender to the fleet before one of our existing tenders gives out or has a repair need that makes no economic sense. We would like to start the process of requesting specific donations toward the purchase of a new water tender (not brand new, we will be buying used).

Walker Fire is a donations-based department so everything we have and are able to do originates from the generosity of our neighbors and residents including the purchase of large pieces of equipment. Obviously the more the community is able to donate to our water tender objective, the more options we will have in purchasing the tender and so we would humbly request \$1000 donations to this effort with the understanding that should there be any excess, it would remand to the department's general fund.

The oncoming fire season also means that restrictions on burning, chainsaw work, welding and even smoking outside the home imposed by Yavapai County will also be here soon. Restrictions usually start in late April or early May and last a week or two past the start of the July monsoon season. If you have work around your property that involves any restricted activity we would request you complete that work before the restrictions commence.

One very important reminder for all residents is that if you have an emergency do not call a firefighter who is a friend or neighbor, if you have an emergency you need to call 911. We had one instance where a resident delayed the response they got to their emergency because they tried to call several firefighters directly, none of whom were home. Your fastest response to your emergency will come from your calling 911.

Last year's Chronicle ran this announcement and we have since had some Members ask for the information again. The Yavapai County Sherriff's Office announced the new ENS in July 2012 with an ever easy way to register your contact phone numbers and property locations in Yavapai County. Look for the "emergency notification" tab at www.ycsoaz.gov, follow the prompts for your opt-in registration and preferred phone number, contact method (email, text, voice...), and enter your property address. The site will convert the address to GPS coordinates automatically and will confirm registration once saved. You should note that all Yavapai County published residential and business landline phone numbers are automatically included in the database, registering with the site will permit you to add additional contact methods (cell phones). WFPA Member eligibility to vote is defined by the WFPA bylaws, Article III "Members Voting" and summarized as owning or participating in the ownership of property within a three mile radius of the Fire Station, property included in the Potato Patch Area Association or otherwise accepted as a Member under guidelines/criteria adopted, from time to time, by the WFPA Board of Directors.

The number of total votes eligible by Members shall not exceed one vote per Member and no more than two votes for property ownership held in "joint" ownership interest as defined in Section 3.2.4.1 of the WFPA bylaws. The total votes eligible are limited as defined, regardless of the number of parcels owned or ownership participation.

Proxy will be verified for eligibility and against a Member roster with a record date of April 3, 2015 proxy qualification will be reviewed and verified with final eligibility determined by the WFPA Secretary. Any proxies not signed, not in proper order or not matching the Member roster will be set aside and considered invalid.

WALKER TRASH COLLECTION SERVICES

Walker Trash Collection Service continues to provide fee for service household trash disposal to its members. Dumpsters are located on the Fire Department property behind the Fire Station at 4980 E. Walker Rd.

Walker Trash collections Service continues to be popular. We have been offering 6 month subscriptions for those of you who only visit during the summer months. The dumpsters are not only a service of convenience for Walkerites but in large part to avoid having people burn trash with the resulting fire danger that it produces.

The dumpsters are for household trash and garbage only. No matter how tempting, hazardous material, construction debris or slash clean up should not be put in the containers. We base the number of containers and pickups on subscriptions for household trash, construction material causes overfilling and extra cost.

The fees are as follows:

Full Year = \$180.00 (\$15 a month)

6 Months = \$120 for 6 months (\$20.00 a month)

One time/special use = \$30.00 a month

DONATE \$1,000 or more to the WFPA and we throw in a year's subscription to the Trash Collection

There is a link on the web site at <u>walkefire.org</u> where you can find the agreement. Send your checks and signed agreement to the WTCS P.O. Box 10174 Prescott, AZ 86304. The accountant keeps the records, Shad Bruce and Linda Emmett (928) 778-2566 handle the mail, locks and any issues with the dumpsters.

A VERY IMPORTANT Note.....

Remember, our homes are in an area susceptible to fire. If this should happen, you, your family and friends that visit should have an evacuation plan. The Yavapai Sheriff's Jeep Posse will manage the evacuation. However, just in case you are separated from your family in this unhappy type of situation, it will make it much better if you have a plan to meet at a specific location. It is then everyone's job to get there and stay there. Having someone to call to leave messages or your family able to retrieve voice messages is a good idea. Be sure to include pets. These plans can be as simple as meeting at the Safeway in Prescott Valley (the Costco will be a zoo) or an advanced plan with bug-out bags, food supplies and detailed instructions. Anything is better than nothing.

Is your fire extinguisher up to date? What? You don't have a fire extinguisher? Uh-Oh, they are cheap enough and can save you!

Smoke Detectors safe lives. Not if their batteries are dead. When was the last time you checked them?

Make sure you have CO2 detectors too! Less glamour, but can be just as important.

The WFPA Water Use Agreement is now available on the WFPA website!

What is the WFPA Water Use Agreement and why is it needed?

The Water Use Agreement on the WFPA website is needed for two specific reasons;

- 1) The WFPA's only viable local water source is water stored in tanks, throughout our community, at the WFPA station or in limited surface water basins.
- 2) The WFPA needs our Member's consent for stored water and needs to locate and index this "authorized" water in the event of a fire in our community so that our water tenders do not have to lose precious travel time to gather water in Prescott.

If you have stored water or an available tender that the WFPA or fire responders can call upon in the event of a fire emergency, please visit the WFPA website at www.walkerfire.org for more details and consider authorizing your water with the Water Use Agreement.

Please remember a fire anywhere in or near our community is a huge risk for all.





