From The Fire Chief

We are hopeful that our wet and snowy winter will have the effect of shortening the fire season this year which would come as a nice reprieve after the last couple of years, but it is too early for any visibility on that outcome.

Usually in May, the county issues restrictions that prohibit fires, which means no burn piles, no warming fires, no smoking outside and no work outside that generates sparks.

In case it is not clear;
THIS INCLUDES PRIVATE PROPERTY.

We are all stakeholders in this, the way we succeed in preventing fires is by working together to not only watch our own behaviors but also by talking to our neighbors and talking to visitors.

If you rent out your cabin, please take extra time to explain the dangers to your renters.

Please start cleaning your property now, before the fire season starts. It would be far better to have only a couple of hours of cleanup in June if we are threatened by a fire as opposed to several days' worth of cleaning to do.



The department will again post the signs pictured below for the fire season that say Fire Ban! No Burning!



If you live on a relatively busy street, or on the way to some sort of popular destination up here (like the Charcoal Kiln as one example) we're hoping you'd take a sign or two and post them strategically when the fire season starts (we'll notify you as to when to post the sign).

This winter we had a lot of problems with people leaving cars at the fire station without permission due to road conditions as well as thinking it's OK to leave cars there for social events.

This is **not OK** to do as indicated by the many signs on the grounds.

Very simply, this impedes department personnel's ability to respond quickly if they



have to spend extra time looking for a place to park.

Further, one person left a pickup and trailer parked in such away as to partially block our way to refill the water tenders.

There have been others along our 50 year long road. Names like Al Powell (some of the old timers refer to the old single bay fire station now used for storage as the Al Powell Building).

I've found the receipts for the building the WFPA built on the Shelton Mine Tailings as a 2nd firehouse built by my father Jess and others, Rocky Flegal from the Potato Patch, Tom and May Russell (Tom ran a small grocery store at what is now Hummingbird Hill before the first fire Station was built).

The WFPA has been clicking along pretty nicely these past few years.

Your Board has been busy managing this business and watching the bottom line grow for which we thank you for your continued support.

We are currently working on the 2019-20 budget. Besides the basic operational needs of our business, there are a few items at

the top of our list that we are discussing a plan for; the maintenance and age of our fleet/equipment and the maintenance of our buildings.

(\$1500.00 for a set of tires that age out is on the low side of costs for some of these trucks.)

We're looking for a utility truck to replace one of the older trucks we just sold.

We are also establishing a maintenance schedule for the buildings. The Powell Building (referenced before) is in need of some work to keep it safe from the runoff that flows down the hill from Good Hope and Champion Roads.

Water flowing by in Lynx Creek behind the firehouse has been quite entertaining for many Walker Kids (and adults) hanging out at events at the fire house.

We are also moving forward with the plans for the building in Potato Patch.



Our Fire Chief Roger Nusbaum has been doing a fantastic job and has a good group of dedicated Volunteers that continue to train and prepare for all sorts of situations that come with a community like ours.

Roger and his crew have just undergone an ISO inspection (needed in order for us to keep our 8b rating).

The Fire Fighters continue their physical training and have to pass the arduous "Pack Test" in order to keep on the front line fighting fires.

Remember they are all volunteers - Thank You!

We're in the middle of the next Chip & Haul coordinated by Loren Bykerk and his Firewise efforts. There should be additional information for you within this newsletter.

Thank you Loren for taking the lead and continuing to work with the WFPA on this effort.

With each Spring, there are always new people moving into our Community. If the opportunity comes up please tell them about all the events we hold at the Fire House, that the WFPA is a communal effort, and all are welcome.

Sometimes it's hard to for newcomers to grasp that we are not supported by tax dollars in any way.

Your contributions can come in many ways. It's not only financial. We need Volunteers for things like working around the station for clean up and fund raising events like Walker Day, the Pancake Breakfasts, Bingo, Kids Day and Fire Fighter Appreciation Day.

Proxy and Instructions

As provided for in the bylaws of the Walker Fire Protection Association, Inc. ("WFPA"), proxy voting is permitted for the Annual Meeting which will be held at the WFPA Fire Station located at 4980 E. Walker Road, Prescott, AZ 86303, at 9:00 a.m., Saturday, May 25, 2019.

Proxies are available upon request by email at secretary@walkerfire.org, or by phone request at 480-223-8034 or available for download on the WFPA website at www.walkerfire.org.

The proxy must be correctly completed, signed and returned by mail to WFPA, PO Box 10174, Prescott, Arizona 86304 or emailed to secretary@walkerfire.org, attention WFPA Secretary no later than Friday, May 24, 2018, or can be physically delivered to the WFPA Secretary at the Annual Meeting by 9:00 a.m., the day of the vote.

WFPA Member eligibility to vote is defined by the WFPA bylaws, Article III "Members" and summarized as; 1) owning or participating in the ownership of property within a three mile radius of the Fire Station, property included in the Potato Patch Area Association or otherwise accepted as a Member under guidelines/criteria adopted, from time to time, by the WFPA Board of Directors and 2) consent by State Statute as defined in section 3.1.1.2 through 3.1.1.2.2.6.

The number of total votes eligible by members shall not exceed one vote per member and no more than two votes for property ownership held in "joint" ownership interest as defined in Section 3.4 through 3.4.6 of the WFPA bylaws. The total votes eligible are limited as defined, regardless of the number of parcels owned or ownership participation as defined in section 3.9 of the WFPA bylaws.

Proxy will be verified for eligibility and against a Member roster with a record date of April 18th, 2019. Proxy qualification will be reviewed and verified with final eligibility determined by the WFPA Secretary.

Any proxies not signed, not in proper order or not matching the Member roster will be set aside and considered invalid.

A proxy form is needed for each person voting. Joint owners may use one form.

Are You Ready For The Upcoming Wildfire Season?

We have been blessed with a wet winter this year. This is good news since the increased moisture may slow bark beetle infestation.

However, historically, wet years tend to foreshadow busier fire seasons. This, on the surface seems counter intuitive, but maybe it is due to taller grasses and more weeds?

Whatever the reasons, we must remain ready by taking personal responsibility to prepare long before the threat of a wildland fire.

Create defensible space; space around your home where firefighters can effectively defend your home from fire without endangering themselves.

Do this by using fire-resistant landscaping and harden your home with fire-safe construction measures.

Consider something as simple as a 5-10 foot border of gravel surrounding your home to break up the fuel path to flammable surfaces.

Assemble emergency supplies and belongings in a safe place. Plan escape routes and a meeting place, and make sure all those residing within your home know the plan of action. Practice it.

Stay aware of the latest news and information from local media, online media sources and public safety.

When instructed to evacuate, leave early and do not jeopardize your or your family's safety by staying to defend or waiting until the last minute.

To obtain additional information on preparedness, plan to attend a Firewise Day and/or a Preparedness Day.

Watch for announcements regarding upcoming event times and places.

TRASH COLLECTION SERVICES

The subscription runs January to December for the 12 months. Six month subscriptions are generally April-September or May-October.

The rates are \$180.00 for 12 months, \$120.00 for 6 months or \$30.00 for a month.

We change the lock combination at the end of January.

We operate this service for your convenience and to avoid people burning their garbage, especially during the dry months.

We have struggled with volume issues because there are a few people who continue to leave the locks open and a few people who use the dumpsters to deposit all sorts of things that are not household garbage.

We've had appliances, rolls of carpet, construction debris even a kitchen sink and cabinets.

This service is for household garbage.

Please take other items to the dump yourself. That includes yard trimmings and large boxes.

If the dumpsters are full, don't just put yours on the ground.

The City of Prescott Transfer Station is located at 2800 Sundog Ranch Road, just north of Prescott Lakes Parkway, off Highway 89 and is open from 8:00 a.m. to 4:00 p.m., Monday through Saturday.

The service comes Monday and Friday to empty the dumpsters. If you can, time your trips to take advantage of that schedule.



I know the weekenders like me need to use them on Sundays and they can be full, especially if they've been left open or when non-household debris has been placed in them.



Who Is Baby Claude?

When I grew up, I went on a lot of camping trips with my church youth group. Two of my favorite places to visit were Joshua Tree and Death Valley.

Both are filled with old mines, ore mills, and abandoned buildings. We slept in a sleeping bag, on a tarp, in the dirt, or in those old buildings.

That's where I got my appreciation for the outdoors, for dirt roads, and for the history of those places.

The mining history of Walker is one of the factors that really drew me to this place and why I love living here.

As a real estate agent, I was recently asked to look at a vacant lot that the owners were considering selling.



As I rolled up at the location, I saw a small picket fence around a grave. The headstone was faded painted wood, and it said:

Our Darling Baby, Aug. 7, 1910 Claude Miller, son of A.W. & L. Miller

I knew that John Miller, and his two sons, Jacob and Samuel, came here in the original Joseph Walker expedition in 1863. Could they be related?

I asked Loren ByKerk about it and he sent me links to web pages with detailed information about this grave.

(Loren seems to know everything about Walker.)

Kathy Block, the author of the web pages had found the death certificate of baby Claude Miller and she says:

"Claude Miller was born prematurely on August 7, 1910, and according to the physician (who came from the Poland area), death was at 10:15PM from 'inanition'. The baby lived only 17 hours."

"He was buried by his father, Archie Miller, listed as 'undertaker' at 'Walker'. Claude's parents, Archie and Lillian Miller, were both originally from Nebraska."

So, baby Claude was no relation to the original Millers, but his family lived here in Walker, at least in 1910.

I'm sure their heartbreak was as deep as anyone's today would be, if we lost a child.

The people who lived here over 100 years ago were as real then as we are today. They worked hard to scrape out a living. They aren't just stories in a book.

If those people hadn't come here and established those mine claims then, which made this private property, this entire valley would be National Forest today.

We would not have our homes here. We wouldn't live here.

I appreciate being able to live here just a little bit more, knowing something about baby Claude and his parents.

If you search for and find the grave, remember that it's on private property, but it can be seen from the road.


