## 1.0 – Approve Agenda

- Sent out revised 21/22 Budget proposal.
- Note discuss 5065 Depreciation expense \$8721 May not be a valid budgeting concern.
- Bingo had a great turn out netting \$235
- Ongoing bank migration, \$100K has been transferred, Most debit cards have been issued. Still need to transfer auto pays and deposits. Targeting end of July to be on line with Wells Fargo.
- WTCS Budget \$27,000 per year expense. Will use this number as a balance target for the checking account.
- PO Box key currently under Vic Henken's control. He would have to go to the post office and release to one of us.
- Donations for this month were \$11,283.57
- Expenses for this month were \$28,313.37 (not including payroll)

## **WTCS**

- Total Liabilities and Equity is \$38,685
- Resolved accounting questions between WFPA and WTCS. Some funds may still show due to how funds are received and paid. Example - someone donates \$1000 to WFPA, \$180 is owed to WTCS for service granted due to generous donations. All is now cleared under 4300 Dumpster revenue.

#### Fleet -

- Squad 81, the new vehicle, is in service had has exceeded expectations. We
  will be doing some inexpensive modifications to the cargo area and it will
  need new tires before winter comes.
- Both Engine 86 and Brush 85 have had their annual servicing and pump tests which are vital for the ISO process. Devine Diesel in Dewey has serviced two of our water tenders for general maintenance thus far and finishing up the third one. The tenders require a different type of pump test that we can do ourselves with a pitot gage. We'll also need to still do annual servicing on Brush 80 and Brush 83.

#### Facilities-

## Personnel -

- Brush 80 has been called out two more times since last month. It went for just one day to the White Tanks Fire and has been at the Mescal Fire near Globe since 6/5 (6/6 may have been the first day of actual work).

## PRCC -

The dispatching process for Brush 80 relies heavily on PRCC. I think we
have a very good relationship with them which has helped us ease into this
pretty easily.

## Yavapai County Chiefs Association -
