## 6.0 – Fire Chief Report

#### Calls

- 5 medical, 1 odor investigation

#### Training

Drafting for Brush 80 and 83 and Initial Attack tactics.

#### Fleet

- Update on annual maintenance for the trucks: Engine 86, Brush 80 (thanks to Charlie Reyes) and Brush 85 are completely done. The water tenders have been serviced as trucks but we still need to service/test the pumps. We will need to buy a Pitot Gage to complete the tenders. We still need to figure something out for Brush 83 and we can take Rescue 81 pretty much anywhere for an oil change and other typical vehicle attention.
- CAFMA Fleet had two experienced guys, including Charlie, retire and their ability to take in trucks from other departments is currently zero. We're the only department they've done any work for.
- I believe we need to consider a 4" or 6" lift kit for Squad 81. I am working on getting estimates. It will be expensive. The big reason to get it done is there

are scenarios that we'd be able to get to people through pretty deep, plowed snow. The reason not to do it is if we need it once or twice a winter it might amortize out to a couple of hundred dollars per call. Research will also be put into possibly getting a snow plow for Squad 81.

#### **Facilities**

- Brush 80 had a weeklong assignment on the Rafael Fire. The assignment went well.
- The entire off district endeavor has a lot of moving parts with four or five of us each having specific tasks: Doug Berg, Tina Lee, Charlie Reyes, Lance Gilbert and I also want to acknowledge Inek Contreras at the accounting office. We throw a lot at him and he does a great job.

#### **PRCC**

- Arizona Department of Environmental Quality reached out to us about out burn permitting process. If a community does not have some sort of centralized process for issuing burn permits, then ADEQ steps in. We have a centralized process through PRCC. ADEQ needs to document that PRCC does this for us. They sent me the document which requires parts filled out by us and parts filled out by PRCC. PRCC has the document and hopefully will get it back to us quickly. Nothing is disrupted in the mean time.

## Yavapai County Chiefs Association

- Similar to last month with Cherry Fire, Skull Valley FD reached out. The chief is new and asked for help. I called, didn't reach him and he has not called back.
