

FROM THE FIRE CHIEF...



The big driver this past winter may have been the power outage in late February that lasted several days. The estimates for the duration of the outage in real time varied significantly. Most people had power restored after approximately 72 hours. This may have been about a day short of this incident escalating into an emergency. Walker Fire was in close contact with County Emergency Management starting to plan for resources like show-

ers, toilets and food. The positive that emerges from the outage is that we are on the county's radar should we ever have another incident that does transition from nuisance into emergency.

In terms of calls we continue to be lucky enough to have a light call volume with most calls for service being medical in nature. As a reminder, it would be very helpful to be able to have a list of medications that any patient might be taking. This is potentially crucial in determining what advanced care is provided both on scene but also at the hospital. Additionally, if there is a third person in the home at the time of a medical call it would be helpful if that third person could meet us outside or otherwise wave us down so that we get to the scene faster.

Participation in the department remains at a high going back at least 14 years with 26 on the active roster. We continue to have interest from retiring firefighters from neighboring departments about joining Walker Fire which helps us to enhance the service we try to provide. We continue to engage in regional events with the Prescott fire community and hold joint training exercises with local departments and agencies and plan to continue to pursue these opportunities.

In our report last fall we suggested getting your chimney swept as a preventative measure for structure fires. Now, headed into wildfire season we would suggest cleaning up around your home including the removal of large "dead and down" trees on your property, removing smaller diameter litter and raking in the immediate area around your house.

The fire season will of course be starting soon, likely in early May and running through until the Monsson starts to bring rain in what is

usually early July. It has of course been a relatively wet winter and the statistics that measure drought conditions are nowhere near as severe as they have been in past years which is certainly encouraging should not be taken as a greenlight for complacency. A low fire danger, which is merely an assumption for now, does not mean the threat is not serious.



In most years, the County imposes restrictions on burning,

welding and other activities that could pose a threat of starting a fire and we should expect that to be the case this year. If you have work of this sort that you need to get done, we would request you do so before the fire season starts or after it ends.

Every so often the department needs to make a large purchase, Water Tender 83 most recently, and when these needs arise we reach out for extra help from the community. Fortunately, there is no immediate need for a capital-intensive acquisition but our ongoing budgetary needs do rely on donations from you, reading this letter as well as your neighbors. If you have not already done so, please make your annual contribution today.

The fire department would like to express its gratitude to the community for that it provides us and allows us to do.

FROM THE PRESIDENT...

Hello everyone,

2017 marks the milestone of the Golden Anniversary of the WFPA. We were incorporated on September 11, 1967. (Really September 11th, who knew). What an amazing accomplishment that shows all the hard work, dedication and commitment to our Walker community by our Members.

I think I have mentioned before I have the first Presidents letter in 1967 requesting donations from the property owners to fund the WFPA. It could have been written this year. While much has changed the funding remains voluntary donations by the Members.

I am including a brief look at the early years of the WFPA. I will be talking to a lot more people to get the complete picture of who did what when. I will provide those details in Email blasts throughout the summer leading up to our 50th Anniversary Celebration on Sunday September 3 during the Labor Day Weekend. Mark Your Calendars.

The original WFPA was initiated and formed by Bob Potter, Chester A. Welshenbaugh, Tom Russell and May Russell they approached John Koenig to help because he was a fire insurance underwriter. A total of 17 people participated in the planning and designated themselves as incorporators.

John Koenig and his family are still frequent summer visitors to their cabin on Good Hope Rd.

The only other surviving 'Original' Incorporator is Louise Gribbon.

Welshenbaugh was an employee of the forest service. The first fire truck was actually an Air Force truck acquired from the Forest Service most likely through the State of Arizona Surplus Property Program with approval from the State Fire Marshall.

The first Fire House was on Tom and May Russell's property. They had a carport that had collapsed during a snowstorm in 1967. Tom Russell basically rebuilt it into the firehouse on what is now Hummingbird Hill Rd next to his store (Referred to as "Russell's Store" a place where the kids went to get soda and candy and adults could get a loaf of bread or a quart of milk) This spot was the original starting point to hike up to the Charcoal Kiln (Bee Hive). That first Fire House 'Garage' building now sits behind our current Fire House, I'm not sure if it was rebuilt over the years.

The first fire was shortly after incorporation. It was a fire near the Potato Patch. Someone in Walker heard about the fire from someone in the Potato Patch probably by CB radio and they gathered people up and went up to fight that fire; getting there before the forest service. The Forest Service said the Walker Volunteers looked like a bunch of mad cats working on the fire. The FS started to refer to the WFPA as Walker Wildcats (our first nickname).

Bob Potter was the first President, but resigned due to health issues. He was 74 years old at the time and suffered a pulmonary embolism. (He was a WWI Veteran and carried a Special Sheriff's Deputy Credential. He caught more burglars than I did as a Phoenix Police Officer in the 1960's). He was very active in the Walker Community starting in 1947. He lived to be 96 years old.

After Bob Potter resigned as President, Welshenbaugh became President. The next year Koenig became the third president. Tom Russell was the first Fire Chief and served for a long time.

At some point Al Powell became Fire Chief. The succession of all the Fire Chief's is not clear, but our current Board Member Rudy Erdman was one of them.

I have a large gap from those early years until the mid 1980's the Sumner's and the Lee's became involved.

The first 5 or so Walker Days were held on the Potter place (at the end of Potter Lane). It moved to the open area near Knapps Gulch where Heavenly Heights Loop takes off from Walker Rd. After that it was held at the intersection of Walker Road and Big Bug. After the current Fire Station was built, Walker Day was moved to that location where it is still held today.

In those early years remember there was no paved road and only 16 party line telephones. Communication was by CB radio (ask your parents if you don't know what that is). A Siren was played to notify the community. That Siren sounded every Saturday at Noon.

If a fire was reported the CB network went to work. All those who were able and heard the call or the siren responded. There was no formal training. People showed up to fires in flip-flops, tennis shoes, shorts and shirtless. One event that caused a little stir was a lightning strike in a snag that was controlled by a fire line dug with claw hammers by Matt and Doug Crater. I know I responded in the

early 1970's with a friend from CA to a house fire. I had absolutely no idea what was going on and luckily it was more smoke than fire and more knowledgeable volunteers had a handle on it.

Eventually, in the 1980's, the three day Forest Service Wildfire Academy became mandatory. Proper clothing was issued and required. Five people including Jon Sumner, his son Jay Sumner and James Lee attended a 60 hour course on Wildland Interface Practices. They actually became Incident commanders on fires even outside Walker.

The late 1990's saw the community come together to build the current Fire Station. Everything that's been done is the result of the community making it possible.

I know there are big holes in the details but we are looking for input. If you have any information please let me know.

We owe a large debt of gratitude to those who have given their time, money and effort to build the WFPA to the point it is today. Were financially healthy, are well staffed with qualified volunteers and led by a dedicated Fire Chief in Roger Nusbaum.

We appreciate your continued support.




The tree at the edge of the Firehouse has been taken down.

FROM THE TEASURER...

On behalf of the WFPA I would like to thank the residents of the Walker Community for their generous donations during the first 10 months of the 2016 - 2017 fiscal year. I would also like to thank those individuals and businesses outside of our community that made contributions, both financial and in kind, to support the WFPA. In addition to these contributions we continue to pursue and enjoy other fund raising events such as Walker Day, pancake breakfasts, bingo, merchandise sales and grants from local and federal programs. All of these efforts continue to make WFPA financially sound. In addition we were fortunate during the past year that we didn't have any serious fire or emergency incidents.

Our year-to-date financials for 10 months through March 2017 show Assets of \$283,224. Our Profit and Loss for this same period shows Total Income of \$68,710 versus a budget of \$79,800 and Total Expenses of \$76,694 versus a budget of \$91,371 for a favorable variance in Net Income of \$3,587. No major capital expenditures were made during this reporting period.

As provided for in the bylaws of the Walker Fire Protection Association, Inc. ("WFPA"), proxy voting is permitted for the Annual Meeting which will be held at the WFPA Fire Station located at 4980 E. Walker Road, Prescott, AZ 86303, at 9:00am, Saturday, May 27, 2017. Proxies are available upon request by email at secretary@walkerfire.org, or by phone request at 480-223-8034 or available for download on the WFPA website at wwww.walkerfire.org. The proxy must be correctly completed, signed and returned by mail to WFPA, PO Box 10174, Prescott, Arizona 86304 or emailed to secretary@walkerfire.org, attention WFPA Secretary no later than Friday, May 26, 2017, or can be physically delivered to the WFPA Secretary at the Annual Meeting by 9:00 AM, the day of the vote.

WFPA Member eligibility to vote is defined by the WFPA bylaws, Article III "Members" and summarized as; 1) owning or participating in the ownership of property within a three mile radius of the Fire Station, property included in the Potato Patch Area Association or otherwise accepted as a Member under guidelines/criteria adopted, from time to time, by the WFPA Board of Directors and 2) consent by State Statute as defined in section 3.1.1.2 through 3.1.1.2.2.6.

The number of total votes eligible by Members shall not exceed one vote per Member and no more than two votes for property ownership held in "joint" ownership interest as defined in Section 3.4 through 3.4.6 of the WFPA bylaws. The total votes eligible are limited as defined, regardless of the number of parcels owned or ownership participation as defined in section 3.9 of the WFPA bylaws.

Proxy will be verified for eligibility and against a Member roster with a record date of April 4th, 2017. Proxy qualification will be reviewed and verified with final eligibility determined by the WFPA Secretary. Any proxies not signed, not in proper order or not matching the Member roster will be set aside and considered invalid.





Walker's streets get offical names

Walker community now has official street names.

The county board of supervisors voted to adopt the official Walker Community Street Name Map at its Tuesday, July 6, meeting

The historical significance of the area has been preserved through naming the roads. Accidental, Blue Jay, Combination, Eureka, Goliah,

Accidental, Blue Jay, Combination, Eureka, Goliah, Grasshopper, Hillside, Kate B., Mark Twain, Mary May, Midnight, Morning Star, New Strike Silver Dollar, Stockbridge, Transcendent, and White House are names of mining claims taken from an 1881 map of the area.

According to James Lee, vicepresident of the Walker volunteer fire department, Walker residents wanted to name a road after a longtime resident who was born in Walker, but they were told that a county ordinance would not allow them to name a road after a living person.

A road is named after a man named Rupert, a Walker community native who died fours years ago.

Another street is named Potter, after Alvina Potter author of Many Lives of the Lynx, a book on the history of the Walker area.

It has taken nearly three years of work by community members, the volunteer fire department and various county and state agencies to name the streets and remap the area.

Mountain Bell, APS, the sheriffs department, the Forest Service, the Walker volunteer fire department and a representative from the county planning and zoning department comprised a committee to assist in the mapping and naming.

According to Lee, there are 425 parcels of land in Walker, some with homes, some without.

Some community members were against the road naming, accusing the volunteer fire department of trying to turn Walker into a city with street signs and street lights, according to Lee.

"There has been a big problem trying to identify where people live," Lee said.

Lee told the story of a friend who had a heart attack and lay on

the floor for thirty minutes while he talked the ambulance into where his home was located.

The purpose of naming the roads is to improve emergency services to the area and to bring in enhanced 911 service, Lee said.

The mapping and the street naming of the Walker area is part of a county wide addressing program.

The addressing program was instituted to name all streets and address all parcels so all areas of the county will be eligible for enhanced 911 informational system.

The Camp Verde area has been completed and the Williamson Valley area is 90 percent completed according to information released by the county planning department.



age the evacuation. However, just in case you are separated from your family in this unhappy type of situation, it will make it much better if you have a plan to meet at a specific location. It is then everyone's job to get there and stay there. Having someone to call to leave messages or your family able to retrieve voice messages is a good idea. Be sure to include pets. These plans can be as simple as meet at the Safeway in Prescott Valley (The Costco will be a zoo) or an advanced plan with bug-out bags, food supplies and detailed instructions. Anything is better than nothing.

Is your fire extinguisher up to date? What? You don't have a fire extinguisher? Uh-Oh, they are cheap enough and can save you! Smoke Detectors safe lives. Not if their batteries are dead or if the unit is over 10 years old (cheapies might need to be replaced at 5 years). When was the last time you checked them? Make sure you have CO2 detectors too! Less glamour, but can be just as important.

You should verify your contact phone numbers and property locations in Yavapai County

<u>as some numbers have inadvertently been dropped from this service.</u> To sign up or verify your information, look for the Emergency Notification System dropdown and select the "Click here to sign up" banner at <u>www.ycsoaz.gov</u>. Follow the prompts for your opt-in registration and preferred phone number, contact method (email, text, voice...), and enter your property address. The site will convert the address to GPS coordinates automatically and will confirm registration once saved. You should note that all Yavapai County published residential and business landline phone numbers are automatically included in the database, registering with the site will permit you to add additional contact methods (cell phones, text and email addresses).



Arizona 2-1-1 Community Information and Referral Services is Arizona's referral services site to give help and get help at a community, county, state and federal level. WALKER TRASH COLLECTION SERVICES

TIME TO RENEW YOUR TRASH SERVICE

Walker Trash collections Service runs from January to December. New combinations were set in January so if you would like summer service or need new service, see the information below. Any excess funds from the trash service benefits the WFPA so please sign up as early in the year as possible.

Dumpsters are located on the Fire Department property behind the Fire Station at 4980 E. Walker Rd. They are not only a service of convenience but in large part to avoid having people burn trash with the resulting fire danger that it produces.

We have had some volume issues at times in the past year with construction waste and the occasional large boxes that had not been broken down. The dumpsters are for household trash and garbage only! **NO** hazardous material, construction debris or slash clean up should not be put in the containers. We base the number of containers and pickups on sub-

scriptions for household trash, construction material causes overfilling and extra cost.

The fees are as follows:

Full Year (January - December) = \$180.00 6 Months (you choose the 6 months) = \$120 for 6 months One time/special use = \$30.00 a month

The accountant keeps the records, Shad Bruce and Linda Emmett (928) 778-2566 handle the mail, locks and any issues with the dumpsters.



Water, Water Anywhere?

Wait, my property doesn't have a hydrant! What will my Walker Fire Department do for water in the event of a fire?? Great question and one of the biggest shortfalls of rural fire departments. The WFPA has three water "tenders" which are always filled with 2,000 gallons of water each, in addition a few hundred gallons stored on first response fire trucks. Since we do not have piped water to hydrants, the tenders must transport water to the fire trucks and once emptied, must refill and repeat the process as quickly and safely as possible.

Where do the tenders get their water?

The fire station has 10,000 gallons of stored water and there are some local private contract water tender owners in our community that might be able to respond in the event of need. Otherwise, the WFPA tenders must make their way down Walker Road to refill in Prescott, a long and timely process using precious minutes. And in the event of fire, the water in the tenders and at the station will surely be used up very quickly.

Isn't there anywhere closer the WFPA might access water??

YES and you might be the answer depending on where a fire incident occurs. The WFPA knows there are water ponds, reservoirs, contract tenders and private water tanks scattered throughout our community. But two things must happen before our thirsty tenders can effectively use local water; 1) the WFPA must have authorization in advance and 2) they have to map this authorized water by address/GPS points to know where it is when they need it.

I want to help!

That's great. 





